Dear Parent:

Undisputable evidence on the record of federal and state courts have proven as a matter of law falsification of government records, perjury and fraud on the courts to conceal that the greatest danger to our children and to our national security is found inside our schools.

I am suffering a life-threatening electrohypersensitivity, EHS. EHS is caused by exposure to the same radiation reaching children at schools. Exposure to these types of radiation causes me among other things, swelling of face, eyes, and of vital organs, internal bleeding, rashes, loss of skin, flue symptoms, and breathing, speech, and concentration impairments. I have been home bound for more than 3 years. I have been violently ill many times. I am in pain all the time. Every day is a different nightmare.

Three doctors have diagnosed my health condition as EHS. The Social Security Administration found my electromagnetic sensitivity a severe impairment. Several state agencies and several courts have recognized the legitimacy of my health condition, EHS.

My three school children are also suffering EHS. Their health condition is progressively aggravating by the radiation exposures at school. My efforts to prevent that my children's EHS becomes as in my case life-threatening continues before the courts.

On April 13, 2011, a recognized expert in radiation exposures in schools, Dr. Samuel Milham, testified before the federal court at McAllen, Texas that my children inherited my EHS, that the swelling, black spots and bloody lines on my children's eyes were caused by the radiation exposures at school, and that my children needed to be transferred to another school to prevent further aggravation of their health conditions. See Dockets 57,81, 94, 97, 98, and 101, to Jesus Mendioza et al., v. Sharyland Independent School District et al., Civil Case no. M-11-29 (S.D. TX. 2011)

Officals of the Sharyland I.S.D., SISD, are refusing to follow the doctors' directions to seat my children not in close proximity to sources of radiation, seated my children closer to sources of radiation, refused to transfer my children to another school and to provide instruction at home in retaliation for denouncing their falsification of records to conceal that school children are being exposed to dangerous radiation. Id.

On December 14, 2013, SISD officials admitted before a federal judge, their disability discrimination and retaliation against my children and against myself, when they admitted that their refusal to follow the doctors' directions, and their refusal to transfer my children to another school and to provide education instruction at home was to prevent a dangerous precedent for the wireless industry. Dockets 1, 14, 17 Jesus Mendoza v. Ricardo H. Hinojoda et al. Civil Case No. 1:14-CV-30 (S.D. TX. 2014)

Specific concrete and undisputable evidence before the Courts has proven as a matter of law falsification of records, perjury and fraud on the Courts by SISD officials, by members of the judiciary and others to conceal:

That the wireless radiation reaching children at school causes EHS and other physical harm that defeats the purpose of education.;

That EHS is reaching epidemic proportions and that many school children are suffering EHS;

That the radiation exposures at school cause greater harm on a subgroup of the student population and that these exposures deplete the children's ability to tolerate occupational exposures before their exposures start;

That children suffering EHS and harm by the radiation exposures at school are routinely misdiagnosed and mistreated with medication that aggravates the harm caused by the radiation exposures at school;

That at my children's school, students and teachers are being exposed to 3 radiation carcinogens including Dirty Electricity, Extremely Low Frequency, ELF, radiation and to microwave radiation, MWR; to occupational levels of Dirty Electricity, ELF and MWR, to more than 40

milligauss of ELF radiation, to more than 25,000 nanowatts/cm² of microwave radiation, and to power levels of ELF and microwave radiation exceeding the federal safety limits;

That the schools' WiFi, iPods and iPads are exposing children to more than 25,000 nanowatts/cm² of microwave radiation;

That exposure to less than 25,000 nanowatts/cm² of microwave radiation causes among other things, behavioral and learning impairments, brain, eye, blood, DNA, and immunological damage predisposing catastrophic disease including cancer;

That chronic exposure to Dirty Electricity amounts to exposing school children to ionizing radiation; that this exposure fatigues and makes the immune system to fail allowing catastrophic disease including several types of cancer; that this exposure increase on teachers and students the risk of cancers comparable to the smoking-lung cancer risks;

That chronic exposure to power levels of ELF below the levels reaching students and teachers at school can cause DNA damage, increases the risk of brain cancer about the same risk for lung cancer and exposure to second hand smoke, weakens the immune system to increase by 500% the risk to several types of cancer during the children's life-time, and increases the risk of dying by 450% to children battling life-threatening diseases;

That even short doses of radiation at or above federal safety limits cause harm;

That the radiation exposures at school are responsible for the increasing number of students with learning and behavioral impairments, for the high rate of student and teacher sickness, absenteeism and poor academic performance, and for the increasing number of students suffering lifethreatening and terminal diseases;

That school districts have a legal duty to measure and monitor the power levels of radiation reaching children at school from harmful exposures to radiation at school;

That the initiatives of the U.S. Department of Education and of State education agencies to introduce a massive amount of wireless technologies into the classroom is not to improve education, but to benefit the wireless industry and for private financial gain of the Executive, of school and other public officials;

That the lowering of academic requirements, and school health initiatives are not to improve education, but to conceal the harm caused on children's minds and bodies by the radiation exposures at school, and to conceal that our children's minds and bodies, and the future of our country have been sold to the best wireless vendor;

That the 6000% increase in children with brain damage (From 1 in 10,000 to 1 in 50) was caused by the increase of use of wireless technologies;

That with the rapid increase of wireless technologies and the rapid increase of children with brain damage, in a few years we may have no children left without brain damage;

That the Executive is conducting with our children an extremely dangerous and suicidal experiment bound to cause a national health disaster that can extend generations;

And to conceal that the compulsory radiation exposures of children at school are violating children's rights to accommodate their disabilities and physical limitations, and their right to bodily integrity, and violating parent's rights, including the right in the care, custody, and control of their children's education, and the right to rear children into health, productive, and responsible citizenship.
